### #2– RECAP OF RECAP OF THE GENERAL SPECIAL ELECTION

➤ November 5, 2024

**Director Williams** greeted the BRE and reported on the activities during this election cycle. **Madam Director** stated the election was very successful. Highlighted activities:

- 177 Election Day polling locations opened on-time
- No wait times
- 417K+ electors voted during Advance Voting
- 92K+ electors voted on Election Day
- 29K+ electors voted Absentee by Mail
- Advance voting results to be posted by 7pm due to early tabulation
- The DRE received several Bomb Threats throughout the county

- The DRE Petition the courts to extend hours at 5 locations due to disruption in service:
  - CH Gullant Elementary (UC02C/D) poll extended to 7:15pm
  - Etris Darnell Community Center (UC02A/B/E/F/G) poll extended to 7:45pm
  - Lake Forest Elementary (SS03 & SS03A, SS07A/B/C/D) poll extended to 7:10pm
  - Southwest Art Center (SC02 & SC02A and SC32) poll extended to 7:43pm
  - Northwood Elementary (RW06 & RW13) poll extended to 7:45pm
