### #1– APPROVAL OF AGENDA

**Chair Woolard** entertained a motion to approve the agenda. The motion was made by **Mrs. Crawford**, seconded by **Vice-Chair Heekin**, and carried by a vote of 4-0.

### #2– RECAP OF RECAP OF THE GENERAL PRIMARY RUNOFF ELECTION

**Director Williams** greeted the BRE and reported on the activities during this election cycle. **Madam Director** stated the election was ran smoothly but low voter turnout.

Highlighted activities:

- **76** Election Day polling locations opened on-time
- **3,100+** electors voted during Advance Voting
- **3,700+** electors voted on Election Day
- **250+** electors voted Absentee by Mail
- Advance voting results to be posted by 7pm due to early tabulation
- All election results can be found on the County's website

**Ms. Adams** requested to start reviewing election material at the conclusion of this meeting.

**Chair Woolard** asked **Ms. Adams** to be more specific.

**Ms. Adams** requested Advance Voting numbers per location.

**Mrs. Crawford** directed her to the information in her packet.

**Director Williams** explained that the Unofficial numbers are posted on our website daily and its in front of you. **Madam Director** explained that the AV results tapes cannot be ran until 7pm. The results will be posted on the bulletin board for the public at 7pm.

**Ms. Adams** asked for the Epulse report.

**Director Williams** stated that was not available to pull. **Director Williams** noted **Ms. Adams** asked for recap sheets and **Madam Director** reiterated that the recap sheets will not be available until Thursday/ Friday, when the AV managers return to reconcile their records.

**Ms. Adams** asked to attend the AV reconciliation process.

**Director Williams** responded yes, it is not open to the public but you as a Board Member can attend.

**Chair Woolard** informed Ms. Adams of the removal of Monitoring Proposal was due to the proposer withdrawal.
