#1– APPROVAL OF AGENDA

Chair Allen entertained a motion to approve the agenda. The motion was made by **Mrs. Crawford**, seconded by **Mr. Heekin**, and carried by a unanimous vote of 4-0.

The Board recessed the meeting until 3:15pm to review the Tabulation process.

The board reconvened at 2:35pm to conduct the hearing for electors with challenged status.

#2- RESOLUTION FOR ELECTORS WITH CHALLENGED STATUS

All challengers were sworn-in prior to speaking.

- Sheree Swanson registered at a business address (UPS Store).
- Represented by Mr. Jack Samuels

Vice Chair Johnson entertained the motion to sustain the challenge status. The motion was made by **Mrs. Crawford** and was seconded by **Mr. Heekin** and carried by a unanimous vote of 3-0.

Mr. Jack Samuels commented on Ms. Swanson's behalf as he legal representation.

Vice Chair Johnson implored the audience to contact their State Legislators that passed this law couple years ago. Mr. Vice Chair asked Mrs. Glenn inquired about the comments made regarding inadequate notice to the voters.

Mrs. Glenn explained that all notices were mailed informing voters that their voting status would change, if action was not taken. She informed the board that Ms. Swanson was notified in 2023.

Vice Chair Johnson explained that this law negatively impacted voters. After the 2020 election the General Assembly made significant changes to Election Laws. We did not create them but we are required to follow them by law.

The audience was frustrated with the process. Inaudible comments

Vice Chair Johnson continued to inform the audience of the current law.

- Niesha Baker assumed she was registered to vote when she visited the Department of Driver Services (DDS) in March.

Mrs. Glenn researched Ms. Baker's claim and confirmed what Ms. Baker stated.

Vice Chair Johnson entertained the motion to deny the challenge. The motion was made by **Mrs. Crawford** and was seconded by **Mr. Heekin** and carried by a unanimous vote of 3-0.

- James C. Lloyd went to early vote was told that he voted.
- David Lloyd son of James Lloyd explained that his son has the same name as his father and he believe it was clerical error

The board collectively agreed to allow Mr. James Lloyd to vote and correct the administrative error.
