FINANCE

DATE OF 06/03/2024 REPORT:

PREPARATION FOR ELECTION / WORK SUMMARY:

The Fulton County Board of Commissioners (BOC) approved the 2024 Elections budget for a total of \$34 million which included funding for the 1st four election cycles. The Finance department's plan is to fund the December 2024 General run-off election, if needed, from the overall Fulton County underruns.

The Financial Systems manager has managed the two temporary staffing agencies to onboard temporary employees and to request billing reports for the temporary staff. We continue to meet with the temporary staffing agencies to coordinate their recruiting efforts to fill open temporary positions. We review the temporary staffing agency invoices.

We are reviewing the budget to actual expenses for the March election cycle. We are continuing to process the vendor invoices for our March and May elections. We are following up on vendors that have not yet provided their invoices.

INFORMATION SYSTEMS

DATE OF REPORT: 06.03.2024

May 21st General Primary – Nonpartisan Election: System Specialists conducted Logic and accuracy on voting equipment for the General Primary – Nonpartisan election, provided technical support during Advance voting and election day, and successfully tabulated and reported the election results.

June 18th **General Primary Runoff Election:** The Information Systems staff begin preparation for the General Primary Runoff Election. The main items in preparation are listed below.

- **L&A Testing** The Information Systems staff is conducting Logic & Accuracy Testing and programming all equipment to be used for Absentee by Mail, Advance Voting and Election Day Sites. Logic and Accuracy testing began on June 3rd and will be completed by June 14th.
- **Technical Support** The Information Systems staff will provide technical support for Advance Voting precincts from June 8th to June 14th. Systems Specialists will also provide technical support for all Election Day sites on Election Day, June 18th.
- **Election Night** Uploading memory cards from each Advanced Voting and Election Day precinct and tabulate. Display results and send reports to the SOS.
- **Post-Election** Receive in all voting equipment that was used in the Runoff Election. Conduct final tabulation and prepare reports for certification.

REGISTRATION

PREPARATION FOR ELECTION / WORK SUMMARY:

This Monthly Report provides a summary of the critical registration activities, workload levels, and voter registration statistics for the Registration Division of the Fulton County Registration & Elections Department for May 2024. The primary activities the VR staff worked on in May were supporting Advance Voting and Election Day Poll Workers. Processing returned mail and mailing new precinct cards to over 780,000 voters. List maintenance activities included cancelling felons, deceased voters, merging duplicate records and voter cancellation requests in GARViS (Georgia Registered Voter Information System) and continuously auditing the voter roll.

- Provided support to the polling locations during election day by providing any extra supplies or assistance that were needed.
- Provided logistical and supply support to all the Advance Voting polling locations by sending any supplies or other assistance as requested by the Advance Voting Precincts.
- Provided absentee ballot drop box support by picking up any absentee ballots dropped into the 7 absentee ballot droboxes and transferring them to the Absentee Ballot Division during the May 21, 2024, General Primary Election.

VOTER EDUCATION

DATE OF REPORT: May 31, 2024

PREPARATION FOR ELECTION / WORK SUMMARY:

In May, the Voter Education and Outreach team focused on promoting the General Primary Election across the county, attending various events across cities to ensure citizens were aware of the upcoming election. The VEO also conducted outreach at several senior graduation events to ensure students were registered to vote before graduation.

The VEO manager continues to conduct deputy registrar training for citizens who want to host voter registration drives. The VEO team will continue outreach to senior centers to ensure they know how to vote and provide identification card services if needed.

The VEO team assisted in overseeing the tabulation area and script for election night to ensure all in attendance were aware of the tabulation process and announced all the steps taken for the upload process. The VEO Manager conducted an election day need-to-know interview with several news outlets to increase awareness of the General Primary Election on May 21, 2024. The VEO Manager continues to meet with the external affairs team to discuss collateral for the 2024 election cycle and continues to work to coordinate any request for interviews. The VEO manager assisted in coordinating, training, and implementing the Risk Limiting Audit.

The VEO team will continue to contact schools, communities, non-profit organizations, and government officials regarding scheduling future events. We are developing ongoing outreach opportunities with various groups to strengthen our impact on the community.
