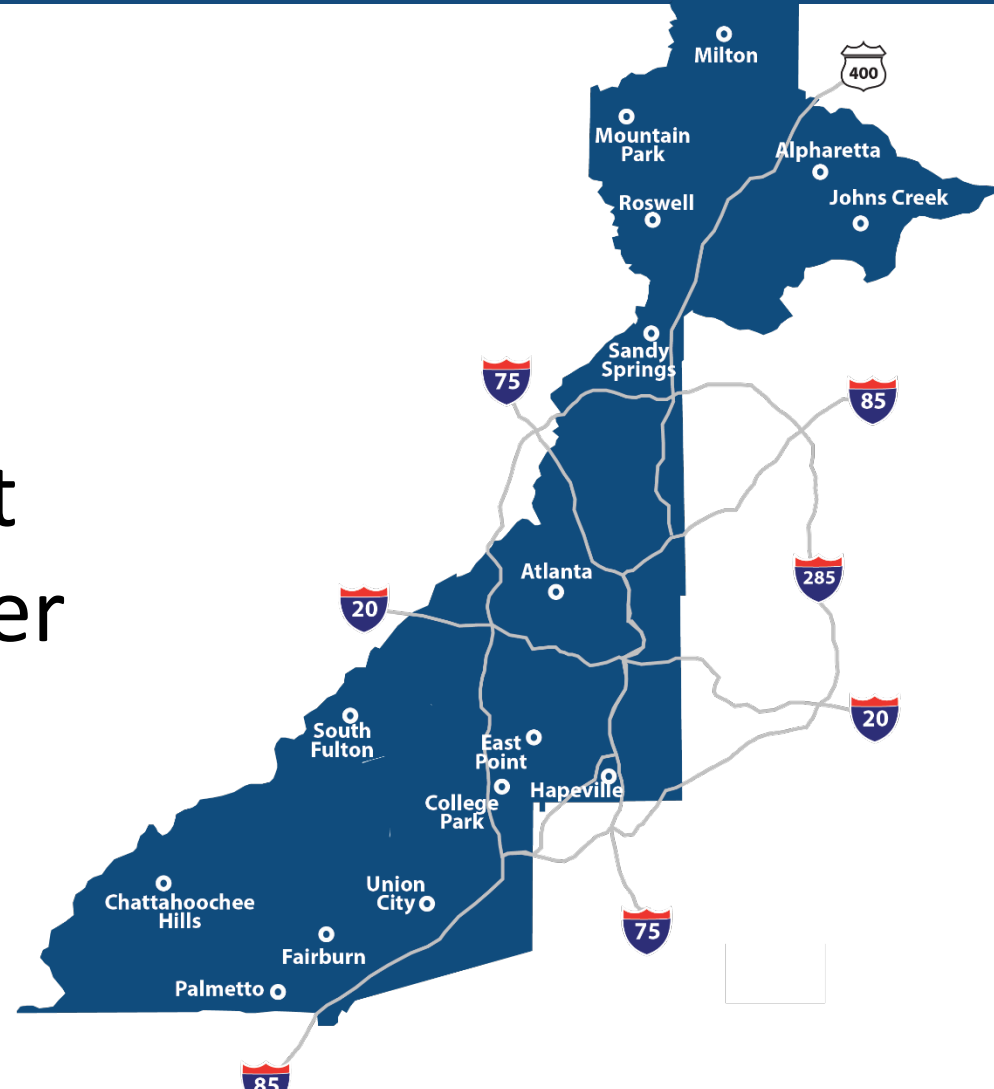

WHAT DOES THE BRE DO?

FUNCTIONS

- Board members are appointed to serve a two-year term.
- The Board sets Registration and Elections policies within Fulton County.
- Has jurisdiction over the Department of Registration & Elections. Supervises the Director, who is also the Elections Superintendent.
- Board Meetings are once a month to set policies and procedures. Special meetings are held on election day to discuss election day activities and to observe the tabulation process. In addition, special board meetings are held to certify ALL Election results by Fulton County, and are then disseminated to the Secretary of State.

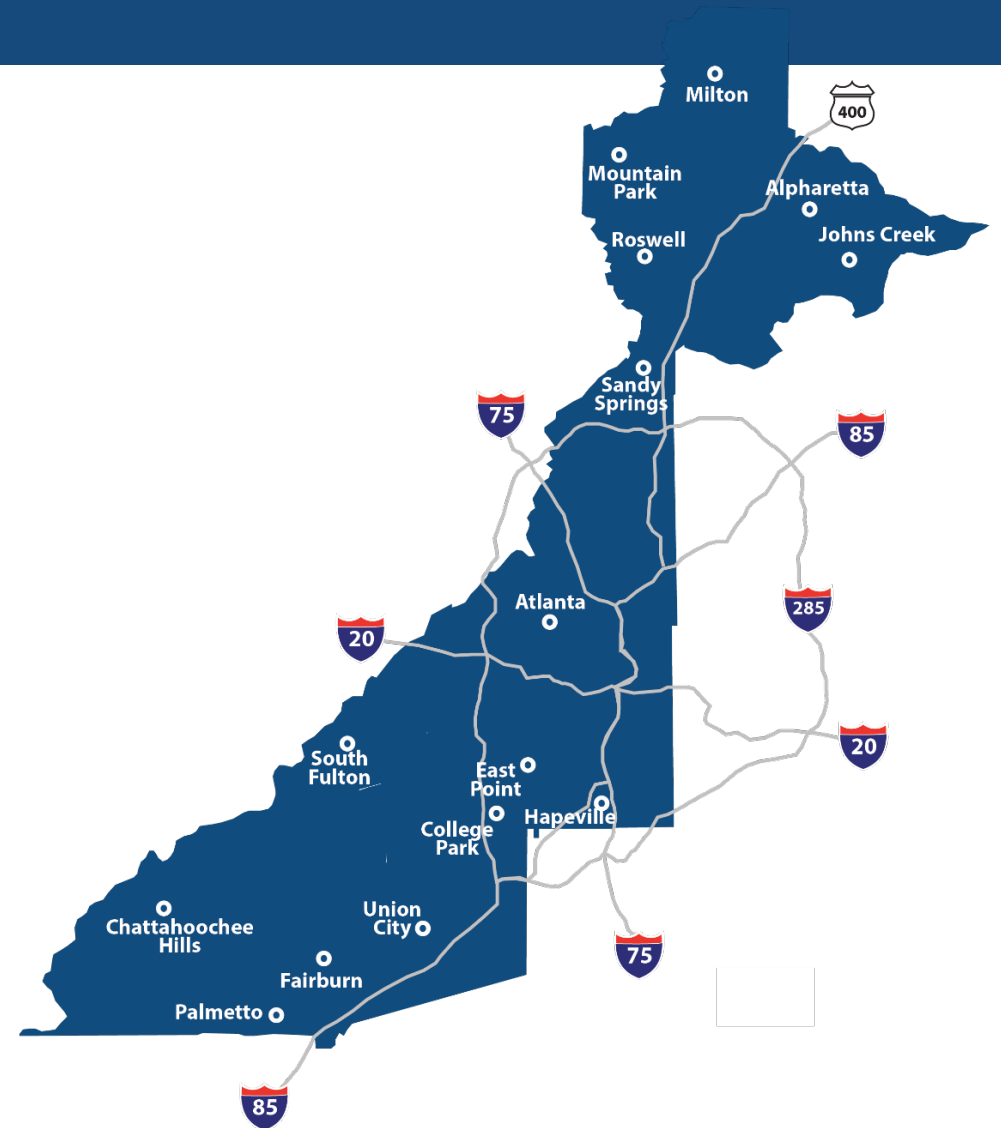

ADMINISTRATION DIVISION

- Responsible for the daily operations of the department to include:
 - Departmental Budget preparations and monitoring
 - Recruitment and employment screening/hiring
 - Procurement
 - Ensuring compliance of Board Policy
 - Candidate Campaign Finance Filings
- Voter Education and Outreach
 - Coordinates Deputy Registrar Program
 - Tracks legislative actions
 - Provides free voter photo identification at outreach events
 - Represents the Department to the Fulton County community





REGISTRATION DIVISION

Total Registered Voters: 871,889 (Active: 770,213 & Inactive: 101,683) as of 8.1.2023

- Responsible for proper registration of all qualified residents of Fulton County
- Maintains accurate master list of registered voters
- Notifies electors of polling place and district changes
- Verifies Challenged Electors
- Verifies Petitions



VOTER REGISTRATION ELIGIBILITY

A person may register to vote if they meet the following criteria (O.C.G.A. § 21-2-216):

- Be a citizen of the United States.
- Be a legal resident of the State of Georgia and the county or municipality.
- Be at least 17 ½ years of age and will turn 18 before the date of the election.
- Not serving a sentence for conviction of a felony.
- Have not been found mentally incompetent by a judge.





ABSENTEE DIVISION

- Responsible for monitoring all outlets for absentee request
 - Thoroughly reviews absentee applications
 - Corresponds with electors via phone, email and/or mail
 - Processes and mails absentee ballots
 - Prints absentee and provisional ballots
 - Cures absentee applications and ballots

Provisional ballots

- Count and verify number of provisional ballots received on Election day
- Research ballots to determine eligibility
- Notify elector



WAYS TO VOTE PRIOR TO ELECTION

ABSENTEE BY MAIL

- Voters may request for an absentee ballot by the designated application.
- Voters may call the main Fulton County Registration and Elections office and an application will be mailed to them for completion.
- First day to mail Absentee Ballots is on **October 16, 2023**.
- 11 days before Election Day is the deadline to October 27, 2023

IN-PERSON EARLY VOTING

- Voters may cast an early ballot in-person on designated days and at designated locations.
- The next upcoming election will be held **November 7, 2023**.
Early in-person voting begins **October 16, 2023**.
 - Municipal and Special Election



ACCEPTABLE ID FOR VOTING

(required when voting in-person)

- Any valid state or federal government issued photo ID, including a free ID Card issued by your county registrar's office or the Georgia Department of Driver Services (DDS).
- A Georgia Driver's License, even if expired.
- University System of Georgia IDs with picture
- Valid employee photo ID from any branch, department, agency, or entity of the U.S. Government, Georgia, or any county, municipality, board, authority or other entity of this state.
- Valid U.S. passport ID
- Valid U.S. military photo ID
- Valid tribal photo ID



ELECTIONS DIVISION

- Responsible for conducting national, state, county, and municipal elections.
- Conducts Election Day/Early Voting
- Selection, preparation and equipping of polling places
- Precinct management
- Recruiting, training and assigning poll workers and processing payroll for election workers
- Maintaining voting equipment and supplies
- Ballot Proofing
- Tabulation of ballots/Risk Limited Audit (RLA)
- Reconciliation

Voting System: The Poll pad, Ballot Marking Device (BMD), and Scanner are all housed in the Carrier system





POLL WORKER RECRUITMENT

- Recruitment & Staffing
 - Hire Approx. 1500-2300 Poll Workers for each Election
- Qualifications:
 - Must be a minimum of 16 yrs. old
 - Resident of Fulton County and/or Fulton County Employees
 - Able to speak, read, and write the English Language
 - Judicious, Intelligent, and Upright Citizen of US
 - Successfully Pass Poll Worker Certification Test



TABULATION / COUNTING

- Tabulation of Absentee In-Person begins at the time advertised on Election Day
- Tabulation begins at 7:00pm on Election Day:
 - Election Day ballots
 - Absentee By Mail ballots



ELECTION NEWS

RECENT BILLS

- **Senate Bill 129**

SB 129 allows employees to take time off for advanced vote as well as provides revisions to time off for election day

- **Senate Bill 222**

SB 222 prevents counties from accepting grants or funding from any outside entities other than the Secretary of State's office.

- **Senate Bill 572**

SB 572 renamed the Georgia Government Transparency and Campaign Finance Commission as the State Ethics Commission.

Municipal Candidate Qualifying Period	August 21, 2023- August 25, 2023
First Day to apply for Absentee Ballot	August 21, 2023
Voter Registration and Address Change Deadline	October 10, 2023
First Day Absentee Ballot can be mailed	October 16, 2023



IMPORTANT DATES

Election	Election Date
Advance Voting Period	October 16 – November 3, 2023
Deadline to Submit Absentee Ballot Application	October 27, 2023
Election Day	November 7, 2023
Deadline to Submit Absentee Ballot Application for Runoff	November 27, 2023
Runoff Election	December 5, 2023
