The Importance of Filing Your Recidivist Notice

The Recidivist Notice is an essential tool to keep repeat offenders, particularly those committing serious violent felonies, off the streets. It ensures accountability by requiring appropriate sentences for fitting defendants. The governing statute, O.C.G.A. 17-10-7, outlines guidelines for recidivist sentencing, with three key subsections.

Subsection (a): If a defendant has one prior conviction, they must be sentenced to the maximum allowable term, though a judge can probate or suspend the sentence if it's not life. For example, an Aggravated Assault conviction, carrying a 20-year maximum sentence, mandates a sentence of 20 years, which could include probation, suspension, or partial imprisonment. For life offenses like Armed Robbery or Rape, the judge must impose a life sentence, as it's the maximum penalty.

Subsection (b): Anyone convicted of a serious violent felony (e.g., Murder, Armed Robbery, Rape) and later convicted of another serious violent felony will face a mandatory life sentence without the possibility of parole.

Subsection (c): A defendant with three or more prior felony convictions must be sentenced to the maximum sentence. If the offense isn't punishable by life, the judge may probate or suspend the sentence, but any "in-custody" time served will be without parole. For life-sentence offenses, the sentence is life without parole. The Recidivist Notice is crucial for plea negotiations and sentencing enhancements in trial. However, its effectiveness is diminished if the prosecutor fails to file the notice, which details the defendant's prior convictions and the applicable subsections for recidivist treatment at sentencing.

Understanding Feedback: Channeling Your Inner Animal

As evaluation time rolls around, the mere thought of receiving feedback can send a shiver down your spine. However, it doesn't have to be an anxiety-inducing experience. With the right mindset and approach, feedback can be a powerful tool for growth. As FCDAO employees, we find ourselves in the exhilarating world of fighting crime. We pour our hearts and souls into our work, pouring over the law, crafting arguments, refining our writing skills and consoling our victim. But then comes the moment of truth: feedback from our supervisor. So, how do we navigate this feedback landscape, especially when we find ourselves caught between two very different animals: the aloof cat and the anxious bunny?

Let's start with the cat. Picture this: a sleek feline, confidently strutting through life, completely unbothered by what others think. That's me when I embrace my inner cat. I can be quite aloof, believing that I don't owe anyone an explanation for my work. When feedback rolls in, I occasionally find myself thinking, "Negative feedback? La la la, you say?" as I yawn and gracefully sashay away. This detachment can be a double-edged sword. On one hand, it allows me to maintain a level of confidence in the work that I do. On the other, it risks shutting out valuable insights that could improve my performance.

Now, let's flip the coin and consider the bunny. This little creature lives in a constant state of alertness, always on the lookout for potential dangers—like a predator lurking nearby. Some may relate to this when it comes to receiving feedback. The thought of criticism feels like a looming threat, and they often feel terrified of being "eaten alive" by harsh critiques. In this bunny mode, individuals become high-strung and jumpy, ready to dart back into their cozy underground den at the first hint of negativity.

Navigating feedback during the evaluation process can feel like a dance between the aloof cat and the jumpy bunny. Finding that balance—where you can embrace your inner cat's confidence while acknowledging the bunny's fears—will help you become better at what you do. Remember, feedback is not the enemy; it's a stepping stone on your path to success. So, the next time you face criticism, take a deep breath, channel your inner cat's poise, and step forward with the bunny's vigilance. With this approach, you'll be well-equipped to tackle the challenges you will face throughout your career.

CIVIL RIGHTS DIVISION

Established in Fall 2021, the Civil Rights Unit (CRU) operates independently from the Anti-Corruption Unit (ACU), focusing on investigating and prosecuting cases involving law enforcement misconduct that result in injury. This includes officer-involved shootings, excessive force, vehicular pursuits, and in-custody deaths. CRU responds to the scenes of officer-involved shootings, assisting the GBI when needed, such as obtaining subpoenas for surveillance footage. Additionally, the unit has investigated and prosecuted cases related to jail contraband, sexual misconduct, fraud, false statements, and GCIC violations by law enforcement officers.

Deputy District Attorney E. Brian Watkins leads CRU, bringing extensive criminal and civil law experience at the state, federal, and appellate levels. Senior Assistant District Attorney Tarrance Miller supports both CRU and ACU. Investigators Deputy Chief Saul Alter and Lt. Christy Manos contribute valuable law enforcement expertise, while Deputy District Attorney Tonya Boykin provides additional support from ACU. Since February 2021, CRU has handled over 106 cases, securing 20 indictments—18 against law enforcement officers. As of December 31, 2024, five cases remain pending or in the Pre-Trial Diversion Program, one was moved to federal court, two are set for trial, and one is on appeal. CRU has resolved 18 cases through plea agreements, often requiring restitution and law enforcement certification surrender. With 38 active investigations, CRU remains committed to justice and accountability in law enforcement.

Criminal investigations of law enforcement officers follow a unique process due to evolving rights and defenses. However, committed to safer public interactions, CRU proactively enhances policing through training and policy development. On January 15, 2025, in partnership with FCDAO Justice Liaison Will McCombs, CRU and ACU hosted an AXON-led training on Taser modifications for Fulton County Task Force Officers. Previously, they trained APD's Fugitive Unit on arrest warrant execution and helped implement a policy for releasing body-worn camera footage to next-of-kin in officer-involved shootings. CRU continues expanding training to prevent violent encounters through better education on Use of Force laws.

With the continued efforts of CRU, Fulton County is working toward eliminating police brutality, strengthening accountability, and ensuring that all members of our community are protected under the law. Through education, enforcement, and reform, we reaffirm our commitment to justice and the preservation of civil rights for all.

HUMAN TRAFFICKING TRAINING



On January 15th and 16th, 2025, a cross section of investigators and attorneys from our office attended the Human Trafficking Training for Law Enforcement, Prosecutors and Child Welfare Professionals in Watkinsville, Georgia. This two-day training was sponsored by the Georgia Criminal Justice Coordinating Council, the Prosecuting Attorneys' Council of Georgia and the Georgia Public Safety Training Center. The training covered the cross section between human trafficking and gangs, labor trafficking, commercial sexual exploitation of children and updates in human trafficking-related statutes and case law.

On January 31st, 2025, Chief Sr. ADA Tarrance Miller was awarded the Alpharetta Department of Public Safety Chief's Community Partner Award for his work and diligence in assisting the Alpharetta Police Department with their Human Trafficking and Internet Child Exploitation cases. As Alpharetta Police Department began to explore new approaches to handle undercover operations with ICAC cases and apprehending offenders who would seek to exploit children in their jurisdiction, they were able to consistently call upon Chief Sr. ADA Miller in the evenings and weekends with their questions and concerns as they investigated these cases. Miller was honored at the Alpharetta Department of Public Safety's Annual Appreciation Dinner on January, 31st, 2025, at The Hotel at Avalon in Alpharetta.


ELDER ABUSE EVENTS



Following a tragic after-school shooting at Benjamin E. Mays High School in February 2024, the Southwest Atlanta community has come together each year to show students that violence does not define their future. On February 12th, members of our team attended the Sisterhood Summit, an inspiring event where young women heard from accomplished women in their own neighborhoods. City Council Member Eshe' Collins delivered the keynote address, with former Atlanta Mayor Shirley Franklin and City Council Member Andrea Boone as guest speakers. Kendall Watkins led a session on healthy communication, engaging students in discussions about cellphone usage and role-playing different ways to communicate based on authority. Angela Johnson spoke about defining femininity and the meaning of being a lady, while January Towles participated in the goal-setting panel, helping students articulate their aspirations and create vision boards.

The following day, the young men of Benjamin E. Mays High School had their own summit, featuring Rev. Louis Negrón, Executive Director & Chief Operating Officer of the 100 Black Men of Atlanta, as the keynote speaker. Assistant Chief Investigator Brian Salter and Chief Investigator Richard Randolph participated in the Street Smarts 101 panel, guiding students through discussions on relationships and interactions with law enforcement.

This annual event continues to empower and inspire students, reinforcing the message that their futures are full of potential beyond violence.

The upcoming Fani T. "If God called you, He will equip you," Dr. Henry proclaimed, offering words of encouragement to the newly sworn-in leaders.


