*<u>Notes:</u>

- Fees for installation of meters include patching of disturbed pavement, but do not include milling and paving of roadway pavement that may be required by the local municipality. Applicants should coordinate with the appropriate municipal Public Works Department to determine any such requirements and either arrange for the municipality to perform the required milling and paving or have Fulton County perform the work and reimburse Fulton County for such expenses at Fulton County's cost.
- 2. Additional fees will be charged for utility relocation and pavement/sidewalk repairs within the water vault area. Meter sizes not listed will be billed at cost of meter installation and system capacity fee.
- 3. Water System Connection Fees (Water Service Application) must be purchased through the Department of Public Works prior to the time the Building Permit is issued by the City or prior to the connection to the North Fulton County Water Service District. Applicants for properties located within the City of Roswell and City of Mountain Park Service Districts must apply for water meter applications from those cities. Applicants for properties south of the Chattahoochee River must apply for water meter applications from the City of Atlanta Department of Watershed Management.
- 4. Water meter replacement includes replacement of stolen and/or repair of damaged meters.
- 5. Irrigation meters starts at ³/₄" up to 1-1/2". Meter Installation and Water System Capacity Fee will be charged. No drop INS for irrigation unless authorized by Superintendent. Meter will be connected by Fulton County. Customer is responsible for ensuring a "RPZ Backflow Device is installed". Your plumber will need to connect your sprinkler system, etc.
- 6. Drop-In Fee: Applies when the meter box is already installed at the service address.
- 7. Domestic Fire Meter: No capacity fee charged, only meter cost.

OTHER ASSOCIATED FEES FOR THE FULTON COUNTY SEWER SERVICE DISTRICT

Replace Sewer Tap and/or clean-out for Existing Residential Customers where the house is more than 1 year old	\$3,546 additional pavement / sidewalk repairs required outside of the repair cost will be transferred to the homeowner for payment
Replace / Install existing residential sewer Customer clean-out	\$2,069 within the public right-of-way or sewer easement; no pavement or driveway repairs involved
Install residential backflow prevention valve	\$1,787 additional pavement / sidewalk repairs required outside of the repair cost will be transferred to the homeowner for payment

*Sewer System Connection Fees (Sewer Service Application) must be purchased through the Department of Public Works prior to the time the Building Permit is issued by the City or prior to the connection to the Fulton County Sewer Service District. "For Water and Sewer Service Connections and Meter Installations, interested parties shall submit an application with the required project's information. Records and Documents Coordinator will process applications within 10 business days. Amount of fees will be based on water meter size, and sewer basin. If customer is on Septic. Contact Environmental Health, 404-332-1801".
